The Application form without fee shall be summarily rejected.

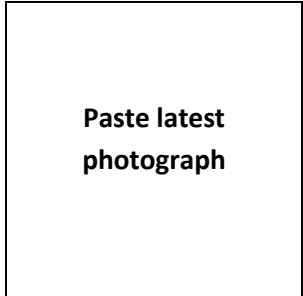
The organising committee reserves rights to decline Registration without assigning any reason.
