Notice Inviting Bids

The Caterer shall be responsible for necessary decoration of the buffet area, installation of requisite no. of decorated sitting arrangement, providing good quality cutleries, and the cost shall include all transported charges also.

The bidders shall have an adequate experience and skills for providing Catering services at Private, Public Undertakings or Govt. Establishments in New Delhi. Bids shall be submitted in sealed envelope and clearly marked with project title "Response to proposals for Catering services at National Green Tribunal, Principal Bench, New Delhi".
