**e.g.**

Item 7 – abc – Adv for SPCB

Item 4 – bcd – Adv. for Resp. 2 & 4

Item 1 – bcd – DM for State of xyz

**After joining**, ensure that –

VIDEO is always 'OFF'

AND

MIC is always 'MUTE'

1. Video should be switched ON only by the parties to a case **immediately** when the concerned Item No. is called for hearing.

2. Mic should be UNMUTED only by the party speaking.
